PROJECT AND LOCATION

The project associated with this RFQ is or shall be located at or near 700 Vandenberg, Hondo, Texas 78861.

PROJECT OBJECTIVE

At the South Texas Regional Airport in Hondo, Texas, a piece of history is about to be reborn. Years ago, the Flight Line Café served as a community hub and favorite stop for pilots, until a fire ended its legacy. Now, the City of Hondo and the Hondo Economic Development Corporation are seeking a visionary partner to bring Navigator's Café to life—a new dining destination that honors the past while embracing the future.

Navigator's Café will be a vibrant, aviation-themed restaurant, designed by renowned architect Thomas Oppelt of Paddle Creek Design. Located next to the runways of South Texas' largest General Aviation Airport, the café will cater to travelers, and local's alike, offering high-quality food and a welcoming atmosphere.

The City of Hondo will handle the construction and delivery of the café shell—all you need to bring is your vision, experience, and energy as the operator of this exciting new business. The café's theme pays homage to the old Hondo Army Airfield, a WWII navigator-training base, blending history with modern culinary experiences.

With support from the Hondo Economic Development Corporation, including favorable lease terms during start-up, and possible other incentives, Navigator's Café is poised to become a key part of Hondo's growth. Located just 41 miles west of San Antonio, Hondo is rapidly developing, with major businesses like Hondo Railway, James Avery manufacturing, TXN Bank and Boise Cascade making it home.

PROJECT SCOPE AND SPECIFICATIONS

- Marketing and promotion of the restaurant to attract and retain customers.
- Financial management, including budgeting, accounting, and reporting.
- Compliance with all health, safety, and regulatory requirements.
- Maintenance of the restaurant facility and equipment.

2. Submission Requirements

- **Cover Letter **: Introduction and summary of your interest in the project.
- **Experience and Qualifications**: Detailed information on your experience in restaurant operation and management, particularly any experience in airport or high-traffic locations.
- **Staffing Plan**: Outline of your staffing strategy, including hiring practices, training programs, and retention efforts.
- **Menu and Concept**: Preliminary menu ideas and overall concept for Navigator's Cafe, including how you plan to differentiate the restaurant menu and drink offering.
- **Financial Plan**: Outline of your financial management practices, including budgeting, accounting, and financial reporting.

 Ability to finance FF&E to complete the interior building shell.
- ** Space Design**: Initial feedback in final design of front & back of house from proposed site/concept plan.
- **Lease Agreement**: Inclusion of preferred lease agreement, if any, provided in RFQ.
- **Marketing Strategy**: Description of your marketing and promotional strategies to attract and retain customers.

3. Selection Criteria

- Demonstrated experience and success in restaurant operations and management.
- Quality and feasibility of the proposed concept and menu for Navigator's Cafe.
- Strength and viability of the financial and staffing plans.
- Effectiveness of the marketing strategy.
- References and past performance in similar projects.

DEADLINE TO SUBMIT PROPOSAL

All proposals must be submitted in a sealed package marked "HONDO NAVIGATOR'S CAFÉ OPERATOR" and addressed to:

The City Secretary must receive (1) original (marked) and (6) copies no later than 4:00 pm of NOVEMBER 20TH, 2024.

PROPOSAL SELECTION CRITERIA

Only those proposals received by the stated deadline will be considered. All proposals, submitted by the deadline, will be reviewed and evaluated based upon information provided in the submitted proposal. In addition, consideration will be given to cost and performance projections. Furthermore, the following criteria will be given considerable weight in the proposal selection process:

- 1. Proposals received by the stipulated deadline must be in the correct format.
- 2. Bidder's alleged performance effectiveness of their proposal's solution.
- 3. Bidder's performance history and alleged ability to timely deliver proposed services.
- 4. Bidder's ability to provide and deliver qualified personnel having the knowledge and skills required to effectively and efficiently execute proposed services.
- 5. Overall cost effectiveness of the proposal.

Hondo Economic Development Corporation reserves the right to cancel, suspend, and/or discontinue any proposal at any time, without obligation or notice to the proposing bidder.
